Dear Resident

The NSW Government today announced a proposal to renew the Explorer Street social housing estate in Eveleigh. The proposal involves redeveloping the entire estate including Explorer Street and Station Place. The social housing managed by Bridge Housing in Rowley Street nearby does not form part of this development. A location map is attached.

The renewal would mean:

- new and better social housing, mixed with private housing in new apartment buildings
- new pedestrian-friendly streets
- public art and open spaces and
- a community facility for residents.

Over the next two years, we will work with the City of Sydney to seek feedback from residents and the local community at key stages throughout the process. The first step is community engagement as we prepare a planning proposal that will be submitted in the coming months to the City of Sydney for their assessment.

If successful, the planning and approval process will take up to two years and no one would be required to relocate before mid to late 2022 at the earliest. At that time, if you are required to relocate you will receive a minimum of six months' notice, and you will be supported throughout the process with the right to return to the new dwellings upon completion.

You are invited to an online information session (webinar) so we can share our preliminary plans, gather your feedback, and answer your questions. Details of the webinars are over the page.
